Chhattisgarh Railway Corporation Limited (CRCL), a Joint Venture of Ministry of Railways and Govt of Chhattisgarh invites applications from qualified and experienced candidates (Retired or serving Person belonging to one of the Engineering services of Indian Railways) for appointment for the position of **Chief Executive Officer (CEO)** of **CHHATTISGARH KATGHORA DONGARGARH RAILWAY LIMITED (CKDRL)**, a fully own subsidiary of Chhattisgarh Railway Corporation Limited (CRCL).
